Family Food Website: Grower Requesting a Form 300





A Form 300 registers a chick purchase to a Family Food Grower and their growing location.

This information allows Chicken Farmers of Ontario (CFO) to alert Family Food Growers when there is a disease advisory issued for their growing area. Awareness of these alerts allows growers to protect their investment and to help prevent to spread of disease in Ontario.

The Form 300 is also required by all Custom Processors when chickens are dropped off for processing.

For chicken purchased from a Hatchery or Broker Dealer in Ontario please contact the store to request a copy of your Form 300.
